- a)Quantum production: 510345TEU(five hundred ten thousand and three hundred forty five teu) with a reduction of 15425TEU (fifteen thousand four hundred twenty five teu) decreased by 3% relative to the same period of the previous year.
- b) Revenues of current activity: 2,911EGP billion (only two billion nine hundred and eleven million pounds) with an increase of EGP 1,364billion (only one billion and three hundred sixty four million pounds) with 88% growth rate relative to the same period of the previous year.
